
## COVID-19Brief



Here is the brief for Friday 18 December 2020.

COVID-19 vaccine update As the COVID Vaccination Programme is starting to gather pace, we're looking to recruit a large number of Vaccinators and Vaccinator Support Workers to locations across Grampian. Currently, Vaccinators need to be registrants of the NMC, GMC, GDC, GPhC, GOC or HCPC, although we are hoping to start recruiting to a new unregistered Vaccinator role in the future. Vaccinator Support Workers help with the smooth running of Vaccination clinics and need no previous clinical experience. All posts will be offered on a fixed term basis until March 2022 and more details can be found on our COVID Programme Recruitment Website (<a href="https://www.nhsgrampian.org/covid-19/nhsgrampian-covid-19-vaccination-recruitment/">https://www.nhsgrampian.org/covid-19/nhsgrampian-covid-19-vaccination-recruitment/</a>). We're contacting recent retirees, emergency NMC registrants, Council partners and those who have expressed interest to seek their support and direct them towards the recruitment website in the first instance. In accordance with Scottish Government Circulars, those appointed to COVID Fixed Term Contracts will not be eligible for redeployment, so any of our substantive members of staff who are interested will need to seek approval in principal from their current line manager to be released on a secondment and should indicate this within their application.

RIDDOR reporting The Health and Safety Executive (HSE), has recently updated the guidance for RIDDOR (The Reporting of Injuries, Diseases and Dangerous Occurrences Regulations 2013) in relation to Covid-19. The most recent guidance relates to the requirement to potentially report some COVID-19 cases under RIDDOR.
